1. INTRODUCTION

The Club **Łódzki Klub Motorowy (ŁKM)** in conjunction SuperEnduro Promoter (Sport UP Agency) organizes SuperEnduro National EXPERT Race as a Support race of FIM SuperEnduro World Championship on behalf of Polish Motorcycle Federation (PZM). Event will be run in accordance with:

5. ENTRIES

All entries must be made till 31.01.2025 17:00 CET time (early entries till 27.01.2025)

Entry fee paid to Organizer is 120 EUR for entries and payment received till 27.01.2025. For late entries (received after 27.01.2025) entry fee is 150 EUR. The deposit for transponder rent is 100 EUR (transponder pack included). The transponder deposit is returned after the transponder has been given back.

The entry form must be accompanied by a copy/photo of a valid competitor's license and starting permission (if applicable), according to point 6.

The number of competitors is limited to 24.

Rider's minimum age is 18. The limit for the minimum age starts on the date of the rider's birthday. Applicants aged over 50 years must attach to their rider's license a certificate of medical fitness (including a normal exercise tolerance electrocardiogram) issued by a doctor recognized by their FMNR.

6. RIDER'S LICENCE

SuperEnduro National EXPERT Race is National Meeting open to Foreign Participation. To participate in the meeting rider must be holder and present at Administrative Control a valid 2025 License as follows:

- PZM "A" MXECC or "A" TR sport license valid in the "Inside" system (QR code to be scanned) or
- FMNs National license + starting permission issued by rider's FMN or
- FIM Enduro, Hard Enduro & ISDE (World Trophy & Junior World Trophy) Article No. 62 401 01 or
- FIM Enduro Junior/Youth/Women/ISDE +Women & Clubs/Hard Enduro Junior Article No. 62 404 01

8. MOTORCYCLES ALLOWED

According to 5.1 of FIM Europe SuperEnduro Cup Regulations.

9. STARTING NUMBERS

According to Art 4.5 and 5.1 of FIM Europe SuperEnduro Cup Regulations. Number plate colors: Black colour background with white numbers

10. RIDERS' BRIEFING

Riders' briefing is compulsory to all riders, will be held according to attached Time Schedule at Atlas Arena Conference Room. Briefing will be held in English language.

11. PADDOCK

Paddock is located inside the Atlas Arena, close to starting gates.

The use of an environmental mat is mandatory at all times, also in the case of electric generators or other generators. It is compulsory for electric bikes to use an electrical insulation mat. Failure to comply with this obligation is subject to a disciplinary penalty of 100 EUR. In the event of non-payment of the penalty or failure to use the mat after the above mentioned penalty has been imposed, the rider will be excluded from the event.

12. BIKE WARM-UP AREA

This area is well delimited near the paddock, outside. It is strictly forbidden to warm-up the bikes in any other location, especially at paddock inside building. When riding during warming-up the rider is obliged to wear a helmet. No riding on green areas is allowed.

13. RACE FORMATS

According to FIM Europe SuperEnduro Cup Regulations

Free Practice: 6 minutes

Time Practice: 6 minutes

Finals race Times: 5 minutes + 1 lap

SuperEnduro National EXPERT Race will have **2 Finals**

14. STARTING PROCEDURE

According to Art 6.8 of FIM Europe SuperEnduro Cup Regulations

15. PRIZE-GIVING CEREMONY

Prize-giving ceremony will be held on the track after the last final of SuperEnduro National EXPERT Race. Riders who qualify for prizes are invited to attend the prize-giving ceremony. If invited, attendance to the prize giving ceremony or press conference is compulsory under a disciplinary penalty.

17. PROTEST AND APPEALS:

Any person or group of persons (rider, entrant, manufacturer, official, etc.), recognized by the FIM and concerned by a decision taken under the authority of the PZM, may ask for redress for the consequences of that decision.

Protest must be lodged according to the PZM Disciplinary and Arbitration Code and the Supplementary Regulations and be accompanied by a fee of € 350,- or equivalent amount in local currency, returnable if the protest is justified.

In general, protests against eligibility of a rider entered, must be made before the start of the official practice. Protests against results must be presented to the Referee within 30 minutes following the publishing of the results. An appeal can be made to the PZM Disciplinary Commission against a decision of the Referee.

In case of FIM combined races an appeal can be made to the FIM Stewards Panel against a decision of the Race Direction.

18. INSURANCE

By endorsing the application form for entry, the FMNR of the rider certifies that the rider is insured in



accordance with the FMNR requirements.

The organizer has contacted third party insurance in accordance with Art. 110.1 of the FIM Sporting Code. This insurance includes a guarantee of the minimum amount as stipulated by the FIM. The Insurance comes in effect 2 days before the first practice and ends after Prize giving ceremony of the meeting. The Organizer disclaims all responsibility for any damage and loss caused to the competitors and their property arising out of an accident, fire or other incident, as well as for damage and loss caused by the competitors to third parties and their property.

19. INTERPRETATION OF THE SUPPLEMENTARY REGULATIONS:

The interpretation of this regulation rests entirely with the Referee or Race Direction. In case of dispute, regarding the interpretation or if there is any difference between the two official texts, the English text will prevail.
